After-care Terms and Conditions

- The After-care is offered as a service by Kloof Pre-Primary School for learners enrolled in the school.
- The times are strictly: from school closing time, until 17.00 hours; OR earlier as specified in the contract you have signed.
- On break-up day for school holidays, After-care will start at 10.00A.M. when school finishes, and the closing times will apply as normal, with exception to break up day at the end of the 4th term when there will be no After-care due to staff development.
- All fees for After-care will be added to your school fee account.
- All penalties will be added to your school fee account.
- Children may only be permitted to attend After-care if their school fees are up to date.
- All the rules that apply to school in the mornings also apply at After-care and the discipline procedures are the same.
- Meals: Happy Tummies can be ordered up until 9.00A.M. on the day on which the meal is required and must be ordered directly with Avril Pullen.
- If Happy Tummies is not ordered, the child must bring a lunchtime snack and juice in a separate lunch box, this must be placed in the container at reception.
- The lunch you provide must adhere to the health norms in the child's note book. No chips, sweets or fizzy drinks will be allowed.
- Juice and biscuits are provided by the school at 3.00P.M.
- Every effort is made to keep the children safe on school grounds and school equipment, but we cannot accept liability for injuries incurred during after-care hours.
- **A late penalty fee of R20 per child per 15 minutes after contract time will be charged and R50 per child per 15 minutes after 5pm.**

Please note that if the Terms and Conditions of the Aftercare Contract are not adhered to, the school reserves the right to exclude your child/children from the aftercare facility.
