



SCHOOL FEES – 2022

Our School Governing Body Annual General Meeting was held on 28 October 2021. A resolution was adopted for compulsory school fees for 2022 as detailed below. According to the SA Schools Act No 84 of 1996, it is a legal requirement of parents/guardians to pay school fees that have been set and agreed upon by a properly constituted meeting of parents. School fees are due and payable on the first day of the school year. However, the Governing Body will allow payments by equal installments to assist parents. The following methods of payments are offered, but for each method chosen parents are expected to adhere to the stipulated dates. In the event of any one payment not being made, then I/we agree that the full amount outstanding immediately becomes payable. In the event of it being necessary for the Governing Body to institute any legal proceedings against me/us in order to recover any amounts outstanding, then I/we hereby agree that in addition to any amounts which may be found to be liable, I/we shall also be liable for all costs incurred by the Governing Body, inclusive of legal costs on an Attorney and client scale, collection charges, tracing costs and interest at the current legal rate as determined by the Minister of Justice. It is the responsibility of the custodian parent to ensure that the fees are paid and that this form is fully completed, signed and returned to school. However, according to high court precedent, both parents are liable for the school fees irrespective of marriage status. Written notice of one calendar term must be given for removal of a learner from the school. Failing this, the equivalent of one terms fees will be charged to the account.

DISCOUNTED FEES
