

The School Governing Body has finalized the budget for 2026 which has been approved by the Trustees. This letter serves to give notice of the increase which is effective from 1 January 2026. School fees are due and payable on the first day of the school year. However, the Governing Body will allow monthly payments by equal installments over 10 months to assist parents. The following methods of payments are offered, but for each method chosen parents are expected to adhere to the stipulated dates. In the event of any one payment not being made, then I/we agree that the full amount outstanding immediately becomes payable. In the event of it being necessary for the Governing Body to institute any legal proceedings against me/us in order to recover any amounts outstanding, then I/we hereby agree that in addition to any amounts which may be found to be liable, I/we shall also be liable for all costs incurred by the Governing Body, inclusive of legal costs on an Attorney and client scale, collection charges, tracing costs and interest at the current legal rate as determined by the Minister of Justice. I/we authorise the school to do credit bureau searches on me/us and in the event of any school fees due by me/us not being paid, I/We authorised the school to inform any relevant credit bureau and have my/our name listed with them. It is the responsibility of the custodian parent to ensure that the fees are paid and that this form is fully completed, signed and returned to school. However, according to high court precedent, both parents are liable for the school fees irrespective of marriage status. Written notice of one calendar term must be given for removal of a learner from the school. Failing this, the equivalent of one terms' fees will be charged to the account in lieu of notice.

DISCOUNTED FEES Annual school fees paid in full by 28 February 2026 will be eligible for a discount of 2%. A pro-rata discount will be allowed for those children commencing school during the year, providing the full amount is paid by the end of the first month of the learner entering the school.	ANNUAL HOLIDAY CLUB An annual holiday club contract at a discounted rate is offered. This is payable either annually or monthly (in equal amounts) in the same manner as selected for school fees. As this is a discounted rate as detailed above, no refunds or credits will be given for holiday club days missed. A separate contract must be completed for this.
SIBLING DISCOUNT Sibling discount of 5% of the annual school fee only will be granted to second and any subsequent children attending KPP simultaneously.
